We have performed the procedures agreed to with the management of Follow Me Trades, LLC (the Company) as enumerated below, with respect to information provided by management of the Company regarding equity trades listed on the Company's website, *followmetrades.com*, during the period from July 1, 2018 through December 31, 2018. These procedures were performed solely for the purpose of providing information regarding the consistency of equity trade information listed on the Company's website with brokerage statements provided to us by management of the Company.

Our engagement to apply agreed-upon procedures was conducted in accordance with attestation standards established by the American Institute of Certified Public Accountants. The sufficiency of the procedures is solely the responsibility of those parties utilizing the report. Consequently, we make no representation regarding the sufficiency of the procedures enumerated below for the purpose for which this report has been requested or for any other purpose.

Because the agreed-upon procedures enumerated below do not constitute an examination, we will not express an opinion on the agreed-upon procedures. In addition, we did not perform any procedures beyond those enumerated below.

Enumerated Procedures:

1. Obtain from management of the Company a listing of equity trades listed on the Company's website, *followmetrades.com*, for the period from July 1, 2018 through December 31, 2018.
2. Obtain from management of the Company the monthly brokerage statements for persons identified by management as being related to Dean E. Jenkins, the founder and sole member of the Company, for the period from July 1, 2018 through December 31, 2018
3. Determine that the equity trades on the listing provided by management were shown under the "2018 Trade Details" tab on the Company's website at January 30 and January 31, 2020.
4. Determine that transactions appear on the brokerage statements that are consistent with the listing of equity trades provided by management. Document any discrepancies.

Results from Applying Agreed Upon Procedures

The listing of equity trades provided by management of the Company for the period from July 1, 2018 through December 31, 2018, is provided on the attachment to this report.

The equity trades on the listing provided by management of the Company for the period from July 1, 2018 through December 31, 2018, were consistent with transactions appearing on the brokerage statements cited, with the following exceptions:

RUBI – The position was closed September 10, 2018. Published close date was September 4, 2018.

LLY – The position opened on November 12, 2018. Published open date was November 15, 2018.

BABA – The position was not closed by December 31, 2018. Published close date was December 6, 2018

On inquiry, management of Follow Me Trades, LLC stated that

RUBI: Missed closing position in personal account when alert was sent – a mistake

LLY: Alert was sent to customers on 11/11/19, with future entry criteria. Criteria was met on 11/12/19. Date of 11/15/19 on the website was a typo.

BABA: Snapshot of profit for 2018 was booked on 12/31/18, but position held open. This was explained in email to subscribers and guidance offered at that time.
